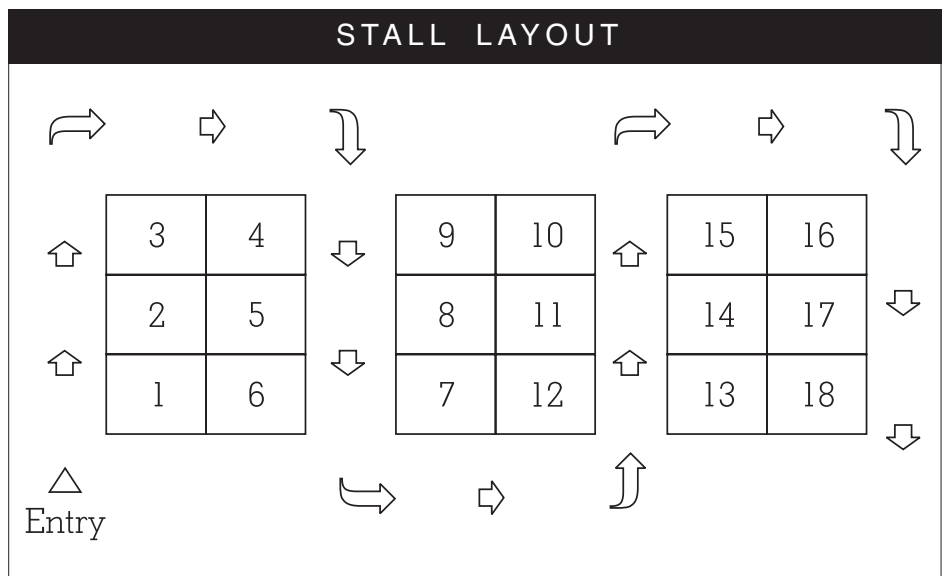

In these Terms & Conditions, the words and expressions mentioned below shall have the following meanings:

Organiser: TechVision Security Consultants Pvt Ltd

Exhibitors: All employees, staff, agent or authorised personnel belonging to a company, partnership firm or individual to whom space has been allotted for the purpose of exhibiting.

Venue: Hotel Taj Gateway, Cochin, Kerala, India

Stall: Exhibition space reserved for an exhibitor

Contract Acceptance

1. The organisers reserve the right to accept or refuse the booth application (without assigning any reason whatsoever) for any exhibit, and once an exhibit is on the floor, to require its modification or removal, whenever the organisers consider such exhibit to be detrimental to their business, professional or ethical interests, or which originates from any organisation whose displayed products do not meet professional standards.
2. Payment must accompany your order and a receipted invoice will be sent. Full payment must be received by 20 Jul 2009. Confirmation will be despatched only after payment has been received.
3. A cancellation charge of 50% of the offer will be levied for orders cancelled up to 2 weeks prior to the event; thereafter no refund will be entertained.
4. The stall representative shall contact the organisers by 24 Jul 2009. In case the allottees would like to have any special arrangement, including extra power and light connections, they should inform this office at least two days before, and such facilities can be arranged by us. The expenses will have to be borne by the concerned allottee.
5. Any commercial liability and all dealings thereof shall entirely be the responsibility of the participants.

Financial Facts

6. All applications shall be accompanied by Cheques / Demand Drafts, payable at Ernakulum, drawn in favour of TechVision Security Consultants Pvt. Ltd., covering appropriate rent for the space. The Cheques / DDs may be forwarded to TechVision Security Consultants Pvt. Ltd., 373, Ward XI, Civil Station-Kunnumpuram Road, Kakkanad, Cochin 682 030, India. Phone or unpaid bookings will not be accepted.
7. The organisers shall make all efforts to allot space as required by the applicant on a 'first come, first-served basis.' The organisers reserve the right of allotment, and their decision in this regard shall be final. However, you will not receive any sponsorship or exhibition entitlements, including allocation of stall location (allocated to sponsors first and then to exhibitors), until the entire amount has been paid.
8. Any tax liability arising out of this exhibition, in respect of any stall, any article exhibited therein, any commodity sold or to be sold from there, or any other matter in respect of the exhibition by any concerned authority shall be borne by the respective allottee. Hence, Central Excise Service Tax at 10.3% must be added to all quoted prices.
9. You must pay any bank charge, in case involved in any transfer of funds to us.

Indemnity

10. The exhibitor agrees to indemnify and hold harmless the organiser, the venue authority, the stall building contractor and their respective officers, agents and employees against all claims, costs and charges of every kind resulting from their occupancy of the exhibit space or its environs for personal injuries, death, property damage or any other damage sustained by the exhibitor or its officers, agents, employees, or those for whom in law they are responsible, or the organiser or a visitor to the exhibition. The exhibitor shall not cause any damage to the venue site and stalls. Any such damage will be made good at the expense of the exhibitor.

Print Entitlements

11. Logos and company / organisation names shall be reproduced in the event colour/s, full colour, or mono, at our discretion. All logos shall be at least 600 DPI at 100% in a JPEG Format. The Logos and other exhibits must reach us at least by 20 Jul 09.
12. No print or web recognition will be given unless payment terms have been met.

Exhibitor Notes

15. You have a limited licence to exhibit. **The stall allotted is non-transferable. The participants shall not share, sub-let, or grant licences for the whole or part of the space to any third party and shall not use the space allotted for any purpose other than for which it is meant.**
16. We are the sole judge of acceptable display items and you will remove them promptly if asked.
17. You must conduct business only from within the confines of your stall. You shall not tout, or place any material outside your stall/space causing obstruction of the aisles.
18. You shall be responsible for any reasonable cost of repairing the stall or premises, should you paint, mark or damage any fixture or fabric.
19. You must familiarise yourself with the participation terms and conditions. Participants shall ensure that their banners, name boards and other display materials do not project outside their respective stalls. They shall also ensure that their sound system, if any, does not cause disturbance to neighbouring stalls or in general prove to be a nuisance. Besides, participants shall take all precautions to exhibit their wares in a dignified and presentable manner.
20. Food, beverage or prohibited items are not permitted at the event unless prior arrangements are made with us.
21. You are solely responsible for any physical loss or damage to your own property. Participants shall take all steps to protect their stall / exhibits during and after exhibition hours, while the organisers will make arrangements for overall security in the exhibition complex. They will not be responsible for any damage or theft of property or injury to persons caused by fire, acts of nature or any reason beyond our control.
22. Participants shall secure their property by adequate coverage of insurance. They shall also adequately secure themselves with public liability insurance.
23. The prefab stalls shall be available only after midnight on 25 July 09. Exhibitors shall remove their exhibits and vacate the premises latest by 2300 hrs on 26 July 09.
24. No hoarding, banner etc. will be allowed at the venue or on the roads in the vicinity unless the design, specification, location and installation have been approved by the organisers.
